- **President's** Eric called meeting to order @ 9:06pm
- **Secretary:** Role Call - Mike and Jamie Hacker, Eric and Candice Siemer, Dan Tillett, Michael and Gina Siano, Shane and Colie Miller, Amanda Ennis, Jenn Stephenson, Shane read report of minutes from last meeting - All in favor
- **Treasurer's** Financial Report - Given by Candice Siemer - All in favor
 - \$24,836 between bank and venmo
 - 85 Registrations still not paid - Candice to send message about making payment arrangements
 - Riddell \$0 balance
 - Amy Luken's stay was \$1,591
 - Oliver family wants to be sponsored
- **Director's Reports**
 - Football- Given by Eric Siemer - All in favor
 - Kurt Spencer to add a couple of weigh-in dates
 - Need to make sure team moms have all paperwork for out of district kids
 - MY has a B team that will play games on Tuesday nights - Cheer is not required to be at those
 - Cheer - Given by Jenn Stephenson - All in favor
 - Still don't have confirmation from Covington School board to be able to post where we are having Comp
 - 71 Cheer teams so far, but should be closer to 80
 - We get all money from ticket sales - \$7 for one session
 - If they buy during presale (wants to offer through Sept 27th) for all day, it would be \$10
 - Want to do wristbands
 - Holmes doing concessions
 - Hospitality room being worked by Amy Luken and Jenn's mom - should only have access if they have to be there all day
 - 6 ppl per organization per session have access
 - Working on corporate donations to cover the hospitality room costs

- Melissa and Maggie doing the running for the judges all day
 - Inviting Scott cheerleaders to work as spotters and warm-up areas - will give them volunteer hours
 - Want to use Holmes sound system for announcing - want to use a DJ for girls music
 - No viewing section on floor
 - Wants to hire photographer and videographer
 - Wants judges to get \$100 gift card for being there all day
 - Wants to buy lanyards for coaches passes (\$28.99 for 100), 2 packs of blue and white parking passes (\$10.99 for 50), security shirts
